AM: Dr. Erdt you have owned the Biopulsar for more than 3 years. For what purpose do you use this device in your clinic?

Dr. Karl Erdt: Sometimes I use it for primary diagnostic; however, more frequently I use the Biopulsar as an additional diagnostic medium and for therapy control.

AM: Are you pleased with the Biopulsar?

Dr. Karl Erdt: I am overall very pleased.

AM: Do the diagnostic results you get with the Biopulsar correspond with the disease patterns of your patients?

Dr. Karl Erdt: Looking at it more broadly, I say, if you look at it more broadly, because we deal with complex biological systems and they generally do not follow a mono-causal, linear way. So the scopes for interpretation are broader, nicer and relatively more exact, than if you look at the things in a mono-causal and linear way.

AM: Does the biofeedback and the aura correspond to the physical and psychological state of being of your patient?

Dr. Karl Erdt: It corresponds to it, if you look at it in at a medium or longer period of time, being subject to a 5complex biological system disease

AM: Did you have the experience that the aura pictures and the biofeedback, are changing immediately after your treatment and hence document your success of treatment?

Dr. Karl Erdt: In a lot of cases you can see the changing immediately, that means before and after the therapy.

In case of psychological diseases this will be surely the case in medium term.

AM: Did you notice that your patients become more open when they see the aura pictures?

Dr. Karl Erdt: You can see this very often and I have the impression that the patients only then notice that they own an organ of vision. This will be best classified through a quotation of Goethe: "If the eye were not sun-like, it could never see the sun."

AM: Does the changing of the aura pictures and the biofeedback correspond to the altered psychological state of your patients?

Dr. Karl Erdt: There are always considerations subject to a medium period of time. The changing of the aura pictures correspond to the state of the psyche, especially if you have in your documentation several states of therapy, one after another which you can compare in one line successively.

AM: How do you manage the interpretation of the biofeedback and the aura pictures?

Dr. Karl Erdt: After the excellent initial seminars and with a little experience, very well.

AM: Can you see any advantages the Biopulsar offers, in comparison to other diagnostic devices available on the market?

Dr. Karl Erdt: For me the very big advantage the Biopulsar and the measuring of the palm reflex zones offers, are like for the neuro-biologist the positron-emission-tomography, the functional MR-Imaging and the spectral analysis of the brain parameters in the EEC.

The second is, that the documentation and the evaluations are available immediately so that you do not only see the symptom but you have also the possibility to establish immediately causal relationships.

One considerable advantage is that everything is very quickly available. It is easy to delegate, so that the handling is not so difficult and that the documentation can be executed on all levels without any difficulties.
